Executive summary

In October 2015, an independent and statistically representative telephone survey was commissioned by Greater Taree City Council to understand residents' opinion towards a proposed special rate variation (SRV) of 6% (excluding rate pegging) for six years, designed to fund improvements to local roads.

An initial dual frame (i.e. fixed line and mobile phone) survey was conducted from Monday November 23rd to Saturday November 28th. A total sample size of 400 residents was achieved. Respondents were not informed of the survey's subject matter prior to commencement of the survey proper. (See Appendix 1 for questionnaire.)

Random sampling error for a survey sample of 400 adult residents is +/- 4.9% at the 95% confidence level.

In response to feedback from this initial survey, a decision was made by Council to revise the proposed SRV to 4.5% (excluding rate pegging), and add a 35% pensioner rebate. Following this decision, a brief follow-up survey (conducted on the evenings of December 15th and 16th) sought feedback from the initial wave of respondents to the revised proposal. (See Appendix 4 for questionnaire.) Of the 400 residents initially interviewed, 327 were successfully contacted and re-interviewed in phase two.

Random sampling error for a survey sample of 327 adult residents is +/- 5.4% at the 95% confidence level.

Among the major conclusions:

- 1. The majority of residents acknowledged that the quality of local roads in the area was poor and required improvement. More than four in five respondents (81%) judged Council's maintenance of local sealed roads to be "poor" or "very poor", and a similar proportion (82%) claimed they were dissatisfied with the general state of local raods.
- 2. Awareness of the proposed SRV prior to the survey was relatively high, with 59% of those surveyed claiming awareness prior to being surveyed.
- 3. Support for, and opposition towards the SRV was evenly balanced, with 40% of respondents supporting the proposal and 38% opposing it. The balance (22%) were neutral or unsure. Support was stronger among younger residents, and weaker among those aged 60-plus.
- 4. Support for the SRV was based mainly on an awareness that additional funds were needed to address the poor state of local roads. Opposition arose mainly from cynicism as to how the SRV would be used, the community's capacity to pay, and concern that Council would not manage the money well. Both supporters and opposers of the SRV expessed concern that the SRV would not result in noticeably improved roads. This indicates that communications regarding the SRV and resulting road work projects should be managed carefully to ensure transparency when spending on road works.
- 5. Respondents were (on balance) willing to pay more rates as long as they saw a direct improvement in road quality. Over half (55%) felt Council should be spending more on road maintenance, and four times as many respondents agreed as disagreed that Council should prioritise better roads over lower rates.
- 6. In the follow-up survey of 327 respondents, 49% supported the revised level of SRV against 32% opposing it. And 84% agreed that a pensioner discount was appropriate for any level of SRV.





Introduction

Background

In October 2015 Greater Taree City Council (GTCC) commissioned Jetty Research to conduct a random and representative telephone survey regarding Council's proposed special rate variation (SRV). The SRV (initially proposed as 6% plus pegged rate increase per year over six years) is designed to fund improvements to local roads. This random telephone survey, part of a wider community engagement program, sought to understand community sentiment towards the condition of local roads and the proposed SRV.

In addition to a random telephone survey of 400 Greater Taree residents, an identical online survey was also offered to those interested in providing feedback (see separate report) Both versions had similar survey objectives:

- ⇒ Understand satisfaction with the state of local roads;
- ⇒ Determine awareness of the SRV;
- ⇒ Determine information sources regarding the SRV;
- ⇒ Understand level of support for the SRV.

Jetty Research, founded in Coffs Harbour in 2006, conducts polling and other social research services for approximately 25 NSW Councils along with a range of State government and academic clients.

Methodology

Survey 1

An initial CATI¹ survey was conducted using a random dual frame (i.e. fixed line and mobile) telephone poll of 400 Greater Taree adult residents aged 18+.2 Respondents were selected at random from a verified random sample residential telephone database of 1,800 residential telephone numbers within the LGA³. A survey form was constructed collaboratively between Council management and Jetty Research (see Appendix 1), based on satisfying the above objectives.

Polling was conducted between November 23rd and 28th at Jetty Research's Coffs Harbour-based call centre. A team of 12 researchers called Greater Taree LGA residents on weekday evenings (excluding Friday) from 3.30 to 8pm, and on Saturday from midday to 5pm. Where phones went unanswered, were engaged or diverted to answering machines, researchers phoned on up to five occasions at different times of the afternoon or evening.

¹ Computer-assisted telephone interviewing

² This sample size was designed to achieve a random sampling error of <5.0%, which is generally considered acceptable by government regulatory bodies and other key stakeholders. ³ Postcodes sourced (from ABS 1270055006C185) were 2424, 2426, 2427, 2429 and 2430. As with any postcode-based source,

some records may lie outside LGA boundaries. Random valid numbers were supplied by SamplePages, a respected supplier of random numbers to the market and social research industry.





The poll was conducted on a random basis, though ensuring an adequate mix of respondents by age and gender and across different sub-regions. Respondents were screened to ensure they were aged 18 or over and were not councillors or permanent Council employees.

To prevent response bias, the survey topic was not divulged until respondents had agreed to participate in a survey on "an important local issue".

A random selection of 400 adult residents was surveyed. Interview time varied from 4 to 15 minutes, with an average of 7.2 minutes.

Survey 2

In response to feedback from this initial survey and other community feedback, a decision was made by Council to revise the proposed SRV to 4.5% (excluding rate pegging), and add a 35% pensioner rebate.

Following this decision, a brief follow-up survey (conducted on the evenings of December 15th and 16th) sought feedback from the initial wave of respondents to the revised proposal. (See Appendix 4 for questionnaire.) Of the 400 residents initially interviewed, 327 were successfully contacted and reinterviewed in phase two. Average interview time for the second survey was four minutes.

Both surveys

Please note that due to the nature of the surveys, not all respondents answered every question. The number of respondents answering each question is marked as "n = XXX" in the graph accompanying that question.

Both survey samples have been post-weighted by age and gender to match the demographic profile of the LGA according to 2011 ABS Census data (usual resident profile). See Appendix 4 for weighting details.

Where differences in this report are classed as significant, this implies they are statistically significant based on independent sample t-scores or other analysis of variation (or ANOVA) calculations. In statistical terms, significant differences are unlikely to have been caused by chance alone. Where a significant difference is evident, the differences are highlighted in blue (significantly higher than the total) and red (significantly lower than the total).





Sampling error

According to the 2011 ABS Census (Usual Resident profile) the total population of the Greater Taree LGA was 46,541, of which 34,852 (75%) were aged 18 and over. Based on this latter survey population, a random sample of 400 adult residents implies a margin for error of +/- 4.9% at the 95% confidence level. (This means, in effect, that if we conducted a similar poll twenty times, results should reflect the views and behaviour of the overall survey population to within a +/- 4.9% margin in 19 of those 20 surveys.)

For the follow-up survey (sample size n=327), sampling error is +/- 5.4% (again at the 95% confidence level).

As Figure i (next page) shows, margin for error falls as sample size rises. Hence cross-tabulations or subgroups within the overall sample will typically create much higher margins for error than the overall sample. For example using the above population sizes, a sample size of 100 exhibits a margin for error of +/- 9.8% (again at the 95% confidence level).




Figure i: How sampling error varies with sample and population size

In addition to the random sampling error, above, there may also be some forms of non-random sampling error which may have affected results. These include respondents without fixed line phones, the proportion of non-respondents (refusals, no answers etc.) and/or imperfections in the survey database.






Sample characteristics (survey 1)


The (weighted) survey sample exhibited the following characteristics:

Graph i: Sample by Gender



Unweighted, 44% of the sample was male against 56% female. Once weighted, the sample reflects the LGAs adult population breakdown (as per 2011 ABS Census) of 52% female/48% male.

Graph ii: Sample by Age




Unweighted, the age breakdown of respondents was 13% aged 18-39, 44% aged 40-59 and 43% aged 60-plus. The weighted figures (shown) reflect the adult population breakdown for the GTCC LGA, as per the 2011 ABS Census.





Graph iii: Sample by Respondent Location



Just over one-third of the sample (36%) resided in Taree⁴, with 18% living in Wingham and 10% in Old Bar. The remainder of the survey sample was widely spread throughout the LGA.

⁴ This is closely aligned to ABS Census 2011 data, which suggests that Taree residents comprise 34% of the population of the Greater Taree City Council LGA. However Wingham residents were slightly over-sampled, representing just over 11% of the actual population.





Part 1: Satisfaction with Council facilities and services


The initial survey commenced with a number of questions relating to satisfaction with Greater Taree City Council- provided services and facilities. Asked prior to the survey's true purpose being revealed, this question was designed to see how satisfied respondents were with road maintenance among a range of other well-known Council services.

KEY FINDINGS

- 1. While residents were satisfied with libraries, the waste and recycling collection, parks and gardens and cleanliness of streets, maintenance of sealed roads rated extremely poorly.
- 2. When asked specifically about their satisfaction with the state of local roads, almost half (49%) stated that they were very dissatisfied, with 33% dissatisfied, 10% neutral or unsure and only 8% satisfied.

Residents were first asked to rate their level of satisfaction with a number of Council-provided services and facilities, on a scale of 1 to 5 (where 1 meant "very poor" and 5 meant "excellent"). Results are presented below and ordered according to the proportion rating each service or facility as a 5 (excellent).

Graph 1.1: Satisfaction with Council facilities or services








Residents satisfaction with Council provided facilities and services varied significantly. Graph 1.1 starkly illustrates community concern with the state of the LGAs sealed roads, in the context of other well-known Council services.

Results indicate that satisfaction was highest with libraries (42% rating libraries as excellent; a mean score of 4.12) and the waste and recycling collection (41% rating waste and recycling as excellent; a mean score of 4.14). This was followed by parks and gardens and cleanliness of streets which received good levels of satisfaction with mean scores of 3.68 and 3.39 respectively and very low proportions of dissatisfaction.

In contrast to the high levels of satisfaction with libraries and the waste and recycling collection, satisfaction with the maintenance of footpaths/gutters was comparatively low, with a mean score of 2.77 and a higher proportion indicating dissatisfaction (36% rating it as a 1 or 2) than satisfaction (27% rating it as 4 or 5).

Of greatest concern was satisfaction with the maintenance of sealed roads. With a mean score of 1.66 and over half of residents (58%) rating it as 1 (i.e. very poor), sealed road maintenance was far and away the most poorly-rated service of the six services polled. In fact just 3% of those surveyed said roads were good or excellent, against 81% saying they were poor or very poor: a net satisfaction score of -78%.

Residents were then asked specifically to rate their satisfaction with local roads:



Graph 1.2: Satisfaction with local roads

The vast majority of residents were dissatisfied with the state of local roads. Almost half (49%) stated that they were very dissatisfied, with a further 33% dissatisfied: hence 82% of respondents were dissatisfied to some degree. One in ten were neutral or unsure, while just 8% of those polled said they were satisfied with the state of local roads.

Results were consistent by age, gender, urban vs. rural, and whether or not the respondent lived in Taree.






Part 2: Awareness, attitudes and support for the Special Rate Variation

The initial survey continued with a number of questions regarding the proposed special rate variation (SRV). These included awareness, information sources and degree of support or opposition.

KEY FINDINGS

- 1. Awareness of the SRV prior to the survey was quite high, with 59% of respondents claiming to have heard about it prior to being surveyed. Most had heard about it via the local TV news, local radio, the local newspaper and/or work of mouth.
- 2. Support vs. opposition towards the SRV was balanced, with 40% of respondents supporting the proposal and 38% opposing it (net support of +2%). Verbatims suggest some cynicism as to how the SRV would be used and concern that Council would not manage the money well. Both supporters and opposers of the SRV indicated concern that the SRV would not result in improved roads.
- 3. Communications regarding the SRV and resulting road work projects should be managed carefully to ensure transparency and ongoing support for the initiative.



Graph 2.1: Awareness of the Special Rate Variation

Awareness of the SRV prior to the survey was quite high at 59% of respondents. As shown in Table 2.1, older respondents were more likely to have heard of the SRV than younger respondents.





Respondents who had heard of the SRV were then asked where they had heard about it:

Graph 2.2: Where heard about the Special Rate Variation



The highest proportion of SRV-aware respondents had heard about it via the local TV news (39%), followed by local radio (33%), the local newspaper/*Manning River Times* (29%) and/or word-of-mouth (25%).

As outlined in Tables 2.2 and 2.3, information sources varied significantly by age and gender:

Older respondents were more likely to have heard of the SRV through the local newspaper than younger respondents. Conversely, younger respondents were more likely to have heard of it via word of mouth.



Females were more likely than males to have heard of the SRV through the local TV news.





Graph 2.3: Have you sought further information regarding the SRV?



The vast majority of those who had heard of the SRV did not attempt to seek further information other than what was passively distributed to them (92%). At time of survey, only 6% had visited the Council website pages relating to the proposed variation and 2% had visited the Council's shopfront at Taree Central. There were no differences by groups of interest.

Those who had sought additional information regarding the SRV via Council's website or shopfront at Taree Centre were asked for their impression of the SRV:

Impressions of the SRV (among those who had visited the website or store front) were varied: some were happy to pay to ensure better roads, while others were sceptical that the money would be spent well.

All respondents were then asked whether they supported or opposed Council's proposal to apply for a SRV of 6% per year specifically to fund improvements in the safety and condition of local roads.

Opinion towards the SRV was balanced, with 40% of respondents supporting the proposal and 38% opposing it (for net support of \pm 2%). A further 22% were neutral or unsure.

Support was highest among those aged 18-39 years, with 47% supporting or strongly supporting the SRV (compared with 36% of those aged 60-plus).





There were no significant differences in support/opposition by gender, urban vs. rural, Taree vs. other or whether or not the respondent had children living at home.

Respondents were asked to indicate their reasons for supporting or opposing the SRV. The full list of verbatim comments is provided in Appendix 2.

Reasons for supporting the SRV focussed on the need for improving the roads, as illustrated in the following verbatims:

- It's quite reasonable, roads do need more work at some places.
- Our streets are terrible and they need the money to do it.
- ? Roads around here deteriorate quickly due to rain, which limits council's ability to fix them due to their limited budget.
- It is very much needed the roads have significant damage, the wear and tear on vehicles is very big here
- We need funding for the road and the state government isn't helping that much, roads are appalling.

There was also some caution in supporting the SRV, with many indicating concern that the money be spent effectively, in the right places and by the right people. Such verbatims included:

- I support only if the council puts the right people in charge. The engineers are making the wrong choices.
- Fair enough we need the money, make sure the money gets spent on the roads and not wasted.
- ! I'll support the rate rise as long as the money goes exactly where is says it does and doesn't get wasted on unnecessary things.

Many of those who opposed the SRV felt that Council would mismanage the funds and the SRV may not result in improved roads. Such verbatims included:

- [Council] can't be trusted with money, every road they try to fix gets worse and worse- particularly Old Bar Road, (which) damages people's cars.
- Fundamentally misuse the rates they already receive from me, an extra 6% is not going to achieve any significant improvement in local roads.
- I live on a road that council will not maintain, I pay my rates and from what I've seen around the area council waste their money on garbage.

Others felt that the roads should be funded through redistribution of Council's existing budget:

- They need to learn to manage the money they have better.
- I don't think council is managing their finances correctly.
- I think the council will just give themselves a pay rise.
- My rates have tripled since I been paying, my roads have not been fixed at all. Should make better use of the funds they receive.





And others felt that there should be an alternative to rate payers funding the repairs:

- House hold owners shouldn't have to pay for all the other people who drive their cars on the road. The financial responsibility should be on the vehicle users not the home owners.
- I am sure there is a better way to mitigate this problem. Roadwork can be done more efficiently with better workers and better planning.

Additional information from survey 2

Following feedback from the original CATI survey, a parallel online survey (see separate report) and other community feedback, Council revised its proposed SRV to 4.5% per annum (plus rate peg) for six years, with a 35% pensioner rebate. Council hence decided to ask Jetty Research to re-interview respondents from the original survey to see how this change affected their opposition or support to the proposed SRV.

Original survey respondents were re-interviewed on the evenings of December 15th and 16th – see Appendix 4. Of the original 400 respondents, 327 were successfully contacted and re-surveyed.

Respondents to the "wave 2" survey were told by researchers:

"The survey we conducted initially was based on a 6% special rate variation over six years to fund improvements to local roads. Based on the results of that survey, and via other community feedback, Council is now putting forward a revised proposal of a 4.5% Special Rate Variation each year for 6 years. Added to the state government's annual rate peg, this would amount to a total increase of 42% over the six years, compared to 62% under the original proposal. Also, as a part of that SRV, Council would increase the Pensioner rebate to cover 35% of the increase over the 6 year period. That would result in an overall increase to pensioners of 27%, again compared to 62% under the previous proposal."

They were then asked the same oppose/support question as in the original survey, but with the revised terms:

"On that basis, can I just ask: To what extent do you oppose or support Council's proposal to apply for a special rate variation of 4.5% per year for 6 years, with some pensioner rebates, specifically to fund improvements in the safety and condition of local roads? "

Their responses are shown in Graph 2.5, next page:



In survey 2, just under half of all respondents (49%) supported the revised SRV proposal, with 32% opposed and the balance neutral or unsure. Support was strongest among females and those aged 60-plus.



Graph 2.5a: Support or opposition towards the proposed SRV (interview 1 vs. interview 2)

Here we can see that the revised proposal has caused a 9% increase in suppport, balanced by a 6% decline in opposition. This would suggest that residents are, on balance, supportive of the amended SRV being proposed by Council.





Respondents were then asked (in an unprompted, open-ended question) why they supported or opposed the revised SRV:

Responses were very similar to those in the initial survey, with almost half of those surveyed acknowledging that something had to be done about the state of local roads. One in five, however, also mentioned that the revised 4.5% was preferable to the 6% per annum originally proposed.


On the opposite side of the fence, 25% of respondents felt that rates were too high already, and/or that ratepayers were struggling to afford them. And one in five felt that Council did not spend existing rate revenue wisely.

Also within the second interview, respondents were asked whether they supported the notion, within any proposed variation, of pensioners paying less than other rate payers. Results are shown in Graph 2.7, next page:

There was strong support for this idea, with 84% of wave 2 respondents agreeing with the concept and just 11% opposed. (This finding was consistent by age and gender.)





Part 3: Attitudes towards rates expenditure on local roads


The initial survey continued with a number of questions regarding Council's currently budget allocation to local roads, and asked respondents to consider whether they should be spending more on local roads to improve the condition without a SRV.

KEY FINDINGS

- 1. Residents were willing to pay more rates as long as they saw a direct impact on road quality for their rate-dollar.
 - Over half agreed that Council should be spending more of its rates income on local roads and half indicated that they were willing to pay higher rates for better roads.
 - This indicates that there is willingness to pay higher rates, as long as there is an obvious improvement in the condition of the roads as a result of that additional funding.

Respondents were first asked if they felt that Council should be spending more, less or the same amount of its existing rates income on fixing local roads (against than 40+% Council claims to spend now).

Graph 3.1: Should Council be spending more, less or the same on local roads



Over half (55%) of respondents indicated that Council should be spending more of its rates income on local roads, 31% indicated that it should be spending the same and 2% felt it should be spending less. There were no significant differences by groups of interest.





Respondents were then asked, in a forced choice-stye question, to indicate where they sat on a sliding 0-10 scale - where 0 meant they only wanted to pay the lowest possible rates, and 10 meant they only wanted the best possible roads.

When faced with such a choice, 11% sided towards lower rates, while 47% sided towards better roads. The balance were unsure and/or wanted an even balance between the two.

This indicates a willingness to pay more rates as long as there is an obvious improvement in the condition of the roads as a result of the additional funding.

Those living in a rural setting were significantly more likely to be willing to pay for better roads with a mean score of 6.12 (compared to a mean score of 5.83 amongst those living in urban areas). As one would expect, there was also a significant difference between those opposed to the proposed SRV earlier in the survey (mean = 4.85) and those supportive of the variation (mean = 6.97). However even those opposed were only just under the neutral score of 5.

There were no significant differences by age or gender.





Graph 4.2: Urban or rural setting




Slightly over half of those surveyed (56%) lived in an urban area (56%), with the balance living in a rural or mixed urban/rural setting.

Almost one-third of those sampled had children living at home (32%) and 68% did not.






Part 5: Final comments and suggestions

Approximately half took the opportunity to provide additional feedback. Their responses have been coded (i.e. themed) and are shown in Graph 5.1:

Apart from general complaints about Council, there was a genuine desire for improved roads in the LGA. There was also a commonly expressed preference for permanent fixes rather than pothole filling, and a belief that the State government should be contributing more to local roads.
