

Council has a 10-year plan for the Bellingen Shire to ensure our future is secure over the long term and is providing quality services to our community. For Council to achieve this, we need to live within our means while balancing the delivery of the best possible services.

Council only has a limited amount of funding to continue delivering our services and maintain our infrastructure. Despite our best efforts to become more financially sustainable, costs continue to rise faster than our income.

We understand that our community places a high value on access to quality services, vibrant places and inclusive events that contribute to our connectedness and sense of wellbeing.

While we know that a rate rise is never welcome, we believe it is an important conversation that we need to have within our community. Council has conducted extensive community consultation to gather feedback on a proposal to apply to the Independent Pricing and Regulatory Tribunal (IPART) for a Special Rate Variation (SRV).

Timeline

- Community Information and Feedback Period 1 December 2022 - 31 January 2023
- Ounder Review
 Contributions to this consultation will be evaluated as part of the SRV application development process. The project team will report back on key outcomes of community consultation to determine if to proceed with application at the February Ordinary Council Meeting.
- Council Meeting
 Council Meeting to review outcomes of consultation and determine if proceeding with SRV application
- O Submit application to IPART
 Council has been successful in an extension
 to the original deadline to ensure meaningful
 consultation with our community can be
 conducted. If Council decides to proceed,
 the application must be submitted by COB
 Friday 3 March 2023.
- O IPART conduct community consultation

 March 2023: Community provide feedback on SRV application direct to IPART
- JIPART decision

 June 2023: IPART provide decision on SRV
 application and Council determines draft
 2023-24 Budget
- Budget is adopted
 June 2023: Council adopts 2023-24 Budget
