Mr Dicker told me even if we do get okay to open mine we will be short of funds I believe coucil have not at any stage tryied to cut costs Council have a office staff ratio of 1 office worker to 1 outside employee ratio being 1 to 1 very top heavy for small council Garden and lawn maintance is a large part of budget mow parks on weekly rotation i believe they could cut back to every second week mow the parks and town entrances using the staff on the week no mowing is needed they could do other jobs spraying weeds road maintance again saving this council will not do The swimming pool costs rate payers \$1000 a day in money \$360.000 a year have asked our general manager Mr Dicker could there be a way of cutting the money lost at the pool i have recieved no comment from him i believe the only way the pool can stay open is use unpaid help from the towns .The pool is leased to YMCA but rate payers still pay the short fall Council cars they just purchased 3 utes for \$65.000 each the council could have bought 3 Chinesse built utes for \$35.000 each the council to me seem to have no understanding of cost savings Why buy any plant items when we are told by council we have no money they keep spending on these items The council has no people skills when you email or speak with them you get your questions are never answered just get told there is a way around it or never answer your emails so i have worked out you must put a time you want your reply and state if no reply sent to a government department that handles the question you get a reply.
