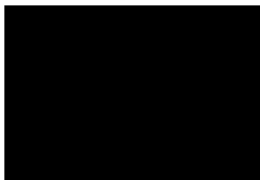
I, Mark Dicker, certify that the Council has complied with the conditions specified in the 2008/09 Special Rate Variation (SRV) Instrument of Approval.

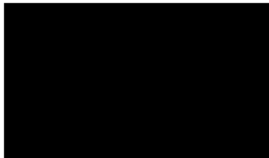

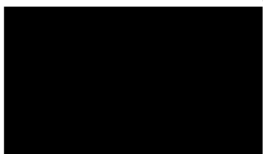

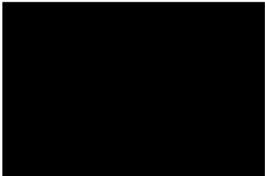
