1 Introduction

Contributions plans set out the local infrastructure required to meet demand from new development, and the contributions a council can levy on developers to fund the necessary land and works.

On 21 June 2022 IPART received a Terms of Reference (ToR) from the then Minister for Planning and Homes to conduct a targeted assessment of certain components of 2 of Blacktown City Council's (the council's) contributions plans. The targeted assessment covers the construction costs for 7 priority stormwater detention basins and associated soil disposal costs in:

- Contribution Plan No. 20 Riverstone and Alex Avenue (CP20)
- Contribution Plan No. 21 Marsden Park (CP21).

In March 2023, the council provided us with the necessary information to complete this assessment. The council then provided additional information in July 2023 in response to a request from IPART.

The scope of this targeted assessment is limited to considering the reasonableness of the council's costs for the priority stormwater detention basins and associated soil disposal costs referred to IPART in the ToR. Our targeted assessment scope does not include reviewing any of the other criteria in the Department of Planning and Environment's (DPE's) Practice Note.

The remaining sections of this Draft Report provide a background on this targeted review of CP20 and CP21, our assessment of the council's proposed revised costs, and draft recommended contributions rates.



2 Assessment of CP20 and CP21

We have reviewed CP 20 and CP 21 several times in the past. In our last review of CP 20 in 2016 and CP 21 in 2017, we made recommendations to remove around \$140 million and \$95 million in stormwater costs, respectively. We found that the stormwater basin and soil disposal costs were disproportionately high compared with those in other contributions plans we had recently assessed. We also recommended that the council investigate a range of strategies to reduce its soil disposal costs.

The then Minister for Planning supported these recommendations. The council did not support these recommendations but adopted CP20 and CP21 so that it could be eligible for Local Infrastructure Growth Scheme (LIGS) funding. The council considers it does not have enough funding to construct the stormwater basins and therefore made a request to include the construction costs of 7 priority stormwater detention basins and associated soil disposal costs back into the plans.

We understand that the council has received funding from the 'NSW Government Accelerated Infrastructure Fund (AIF) scheme Round 2' to recover the costs of building 2 of the basins referred to IPART in the ToR. The council therefore proposes to recover the cost of constructing the remaining 5 basins from the contributions it collects from developers. All 5 basins are contained in CP20.

The council has included in its submission a quantity surveyor report from Mitchell Brandtman (MB) in support of the proposed costs. This targeted review will assess the appropriateness of these costs as presented in the quantity surveyor report, along with other information we receive from the council.

2.1 What is the council proposing to do?

The council proposed a total cost for the 5 basins of around \$75.9 million (\$2021-22) (Table 1). This increases to around \$78.2 million when indexed into \$2022-23. Compared to the IPART approved costs in 2016, the increase in costs for the Eastern Creek catchment is \$17 million (\$2023), and the increase in costs for the First Ponds Creek catchment is \$42 million (\$2023).

2.2 What has our consultant found?

We have engaged a specialist consultant, WT Partnership, to provide expert cost estimation advice on the reasonableness of the council's proposed costs. WT Partnership has produced a draft report detailing their findings, and we have published this with IPART's Draft Report for public consultation.

Some key preliminary findings from WTP include:

- The council's proposed cost of \$78.2 million (\$2022-23) is \$7 million (or 8.2%) less than WTP's estimate of \$85.1 million.
- The difference between the council's proposed costs and WTP's estimates is within reasonable tolerances.
- The range of outturn costs expected for a project of this nature may fall within a +/- 20% of the WTP's estimates.

3 Our draft recommendation for contributions rates

The ToR referred 7 stormwater basins in CP20 and CP21 to IPART. However, because the costs for 2 basins are recovered through alternative NSW Government funding from the AIF, we have allowed zero costs for these 2 basins in this targeted review. One is contained in CP20 and the other in CP21. The remaining 5 basins which have not received alternative NSW Government funding are all contained in CP20.

Our draft recommended contribution rates for CP 20 are set out in Table 2. The council's proposed revised costs would increase the indicative contributions rate^b per hectare by:

- 7.6% in Eastern Creek, and
- 6.2% in First Ponds Creek.

We recommend no changes be made to CP21 contribution rates as the only stormwater basin that is contained in CP21 in this review has received alternative NSW Government funding, and the council is not seeking to recover the cost for this stormwater basin from contributions.
