



NSW public and private water utilities performance indicators

30 November 2022

1 What are the performance indicators?

IPART monitors 3 major public water utilities, and 31 private water utilities^a licensed under the *Water Industry Competition Act 2006* (WIC Act) in NSW to check that they comply with their licence conditions. We collect annual performance data from each utility.

2 Why do we monitor?

We publish the annual performance data to ensure transparency, improve public confidence, provide additional incentives to the utilities to perform to expectations, and enable identification of areas for improvement.

3 How do we monitor?

The Excel workbook (database) presents performance indicator data from 2014-15 to 2021-22.

As the nature and scale of operations vary between utilities, comparisons of performance indicator data can be difficult. Therefore, we do not attempt to provide commentary or draw comparisons between the utilities' data.

4 Who do we monitor?

Information presented in the database relates to the following regulated water utilities:
