### 1. Background

At the Council meeting on 19 September 2023 Council resolved to go to the community and consult on a proposal to apply to the Independent Pricing and Regulatory Tribunal (IPART) for a permanent Special Variation (SV) of either:

- A special variation implemented over one year of 41.5% in 2024-25 (including the forecasted rate peg of 3.5%) or
- A special variation implemented over two years of 25.5% in 2024-25 (including the forecasted rate peg of 3.5%) and 18.0% in 2025-26 (including the forecasted rate peg of 2.5%), representing a cumulative Special Variation of 48.1% and retained permanently.

Community engagement must be undertaken before applying for a Special Variation (SV) under the Independent Pricing and Regulatory Tribunal (IPART) guidelines. IPART requires evidence that the community is aware of the need for and extent of a rate rise.

The guidelines state that Council's engagement approach must utilise an appropriate variety of methods to ensure community awareness and input are received. It is important to note that IPART's assessment is not based on the level of support received from the community but rather that the community was made aware of the impacts of a proposed SV. This summary report has been prepared as evidence of the extensive community engagement undertaken by Council, before a potential application to IPART for an SV.

### Engagement objectives and goals

The Community Engagement Plan – Special Variation, was created to actively engage with the local community providing information in a timely, open, and transparent nature, to ensure that residents and stakeholders remain well informed. A dedicated Special Variation Community Engagement Plan (Appendix 1) was developed based on the principles of Narrandera Shire Council's Community Engagement Strategy 2023.

### 3. Engagement approach

### 4.1 Website

### Launched 19 September 2023

### Action:


A dedicated SV page was launched on 19 September 2023 with a direct link from the Council's homepage. The SV webpage served to provide information throughout the SV consultation process and following the community engagement period. The page was updated throughout the community engagement period in response to questions raised.

### Outcome:

Between September 19 – 3 November 2023, the Have Your Say Special Variation page had 794 views by 363 users, approximately 2.19 views per user, with an average engagement time of 2 minutes and 59 seconds.

355 PDFs were downloaded from the page for viewing.





### Background

At the Council meeting on 19 September 2023 Council resolved to go to the community and consult on a proposal to apply to the Independent Pricing and Regulatory Tribunal (IPART) for a permanent Special Variation (SV) of either a one-year SV of 41.5% in 2024-25 (including the forecasted rate peg of 3.6 per cent) or a two year SV of 25.5% in 2024-25 (including the forecasted rate peg of 3.5 per cent) and 18.0 per cent in 2025-26 (including the forecasted rate peg of 2.5 per cent), representing a cumulative Special Variation of 48.1 per cent over two years.

### What is a Special Variation (SV) and Rate-Pegging?

Normally general rates increase each year in line with an amount set by IPART. This amount is calculated annually based on methodology including a local government cost index and is commonly called the 'rate peg'. For the 2023/24 financial year, the rate peg applied to NSW councils including Narrandera Shire Council is 3.7%. An assumed rate peg of 3.5% for 2024/25 and 2.5% for 2025/26 is being utilised as an estimate for the purposes of this consultation.

If a council's rate revenue is not sufficient to maintain service levels, undertake capital renewals and ensure sustainability, it can apply to IPART to increase general rate revenue by more than the rate peg. This is known as a Special Variation (SV). To apply for an SV, councils must demonstrate to the community and IPART that they need the money and have implemented improvements to be as efficient and productive as possible. Since 2016/2017 79 of the state's 128 general-purpose councils have applied to IPART for an SV. Those increases have varied from just 6.3% (Tweed) up to 92.8% (Strathfield). An annual list of approvals is published on the IPART website Media Release (nsw.gov.au)

### Is the SV increase permanent?

Yes, in this instance, if approved the proposed SV will increase the general rate base permanently, commencing in 2024/2025. The rate base as from the 2025/26 for option one, or from the 2026/27 for option two, will increase by the annual rate pegging limit as set by IPART.

### What will the SV fund?

If implemented the special variation will generate an additional \$2.3m. These funds will be used as follows:

- Ensure financial sustainability.
- Upgrade of the Narrandera stormwater system (loan repayments on Council's share of that cost)
- Maintain existing service levels.
- Staff salary system improvements.
- Technology upgrades including cyber security and a new enterprise management system.
- Compliance including the Audit Risk and Improvement Committee and risk management.
- Infrastructure renewals to reduce the backlog in asset conditions.



### Why is this increase in rates necessary?

Council's income from rates has not kept pace with increases in expenses and this has meant that Council has over time become unsustainable and almost totally dependent on grants for capital renewals. The need to upgrade the stormwater system in Narrandera is an important component of the challenge faced by Council, but it is only one of many factors impacting the long-term sustainability of the organisation. The combined effects of ongoing rate pegging at levels below actual cost, fair value accounting for assets, increasing compliance cost and growing community expectations fuelled by the Independent Pricing and Regulatory Tribunal process have taken their toll.

### When will the decision on the Special Variation be made?

The decision on the Special Rate Variation will be made by Narrandera Shire Council after intensive community consultation has been undertaken.

Following the public consultation period, a further report will be considered by Council in November 2023. At that meeting, Council will make a final decision as to whether it will apply to IPART for the Special Variation. If IPART approves the application, the first stage of the increase will be effective in July 2024.

### Action:

A Special Variation Estimator to allow ratepayers to assess the impact of the proposed Special Variation (SV) on their respective rates. The SV Estimator has been added to help ratepayers better understand how the increase will impact them as the Council continues to ask for the community's view on a proposed SV to ensure long-term financial viability.

### Outcome:

Between 19 September – 3 November 2023 the Special Variation Estimator page was viewed 625 times by 204 Users, an average of 3.06 views per user with an average engagement time of 2 minutes and 36 seconds.

### 4.5 Individualised Correspondence to Ratepayers

Dispatched to Australia Post 2<sup>nd</sup> – 6<sup>th</sup> October 2023

### Action:

A letter, including individual estimates of the financial impact of an SV for both options, was sent to each ratepayer in the shire. The letter outlined what an SV and rate pegging is, if the SV increase is permanent, what the additional funds will be used for, why the council must increase the rates, how residents can have their say and the community engagement sessions. A submission form was also included in the package with a reply-paid envelope.

### Outcome:

3612 letters were dispatched to Australia Post for ratepayers between 2 – 6 October 2023. The mail merge was created on the 22<sup>nd</sup> of September, to be dispatched earlier, however, packaging 3612 letters, submission forms and reply-paid envelopes took more time than anticipated, despite this, the initial timeframe to dispatch was met. As of 6 October 2023, 32 letters have been returned to the sender.

### Narrandera Shire Council Endorses Financial Plan and Seeks Community Consultation in Special Variation Application

Narrandera Shire Council has taken a significant step toward securing the future financial sustainability of the organisation by endorsing the Strategic Asset Management Plan, Delivery Program, Community Engagement Plan, and Long-Term Financial Plan.

During the September council meeting, it was recommended that the council make an application to the Independent Pricing and Regulatory Tribunal (IPART) for the implementation of a Special Variation (SV) commencing in the 2024/25 financial year. The proposed SV options include a one-year SV of 41.5% in 2024-25, including the forecasted rate peg of 3.5 per cent, or a two-year SV of 25.5% in 2024-25, including the forecasted rate peg of 3.5 per cent, and 18.0 per cent in 2025-26, including the forecasted rate peg of 2.5 per cent. These variations amount to a cumulative Special Variation of 48.1 per cent over two years.

To ensure transparency and community involvement, Narrandera Shire Council will commence a comprehensive community consultation process based on the approved Community Engagement Plan for a Special Variation. This process will allow residents and stakeholders to have their voices heard and provide feedback on the proposed rate increase.

Mayor Cr. Neville Kschenka emphasized the importance of community engagement in decisionmaking: "We value the input and participation of our residents and stakeholders in shaping the future of our shire. This is a crucial step in securing the financial stability of the council while ensuring we meet our legislative obligations and community expectations."

The outcomes of the community consultation process will be presented in a report at the council's November meeting. Council will carefully consider the feedback received before making a final decision on the Special Variation application.

The need to upgrade the stormwater system in Narrandera has been identified as a key factor impacting the long-term sustainability of the council. The proposed rate increase aims to provide the necessary funding to address infrastructure challenges and maintain service levels that meet community needs.

Council has undergone a comprehensive assessment of its financial position and believes that a significant increase in income is necessary to ensure its long-term viability. Both IPART and higher levels of government expect councils to be sustainable and capable of fulfilling their legislative obligations.

Council encourages all residents and stakeholders to actively participate in the community consultation process and provide their valuable feedback to help shape the future direction of Narrandera Shire.

### BACKGROUND

At the Council meeting on 19
September 2023 Council resolved to
go to the community and consult on a
proposal to apply to the Independent
Pricing and Regulatory Tribunal (IPART)
for a permanent Special Variation (SV)
of either:

- a one-year SV of 41.5% in 2024-25 (including the forecasted rate peg of 3.5%)
- or a two year SV of 25.5% in 2024-25 (including the forecasted rate peg of 3.5%) and 18.0% in 2025-26 (including the forecasted rate peg of 2.5%), representing a cumulative Special Variation of 48.1% over two years.

### IS THE SPECIAL VARIATION INCREASE PERMANENT?

Yes, in this instance, if approved the proposed SV will increase the general rate base permanently, commencing in 2024/2025. The rate base as from the 2025/26 for option one, or from the 2026/27 for option two, will increase by the annual rate pegging limit as set by IPART.

### **BARELLAN SEWER UPDATE**

Work on the Barellan Sewer Scheme commenced last month with Keane Civil mobilising to the site. The project will result in the town of Barellan being connected to the sewer system, with approximately 5.5km of gravity pipework installed as well as four sewer pump stations within the town and rising mains. The town's sewage will be pumped to a new treatment plant (series of storage lagoons) located along Kolkibertoo Road where it will undergo treatment. ### BACKGROUND

Following the completion of Council's financial reports for 2022-23 a review of the organisation's long-term financial sustainability has been undertaken. A detailed report examining those issues and recommending that Council consult with the community on a significant rate increase will be presented at the September Council meeting 2023.

### WHAT IS A SPECIAL VARIATION AND RATE PEGGING?

Normally general rates increase each year in line with an amount set by IPART. This amount is calculated annually based on methodology including a local government cost index and is commonly called the 'rate peg'.

For the 2023/24 financial year, the rate peg applied to NSW councils including Narrandera Shire Council is 3.7%. An assumed rate peg of 3.5% for 2024/25 and 2.5% for 2025/26 is being utilised as an estimate for the purposes of this consultation.



If a council's rate revenue is not sufficient to maintain service levels, undertake capital renewals and ensure sustainability, it can apply to IPART to increase general rate revenue by more than the rate peg. This is known as a Special Variation (SV). To apply for an SV, councils must demonstrate to the community and IPART that they need the money and have implemented improvements to be as efficient and productive as possible. Since 2016/2017 79 of the state's 128 general-purpose councils have applied to IPART for an SV. Those increases have varied from just 6.3% (Tweed) up to 92.8% (Strathfield). An annual list of approvals is published on the IPART website.

## IS THE SPECIAL VARIATION INCREASE PERMANENT?

Yes, in this instance, if approved the proposed SV will increase the general rate base permanently, commencing in 2024/2025. The rate base as from the 2025/26 for option one, or from the 2026/27 for option two, will increase by the annual rate pegging limit as set by IPART.



The Special Variation Survey was made available on SurveyMonkey and accessed via the web site and social media.



Q2 Which Special Variation option do you prefer?




# Q3 How important is it for Council to maintain the current range of assets provided?


# Q4 How important is it for Council to maintain current levels of service?




# Q7 How important is it for Council to maintain fees and charges at the current levels?


# Q8 Would you like Council to be and remain in a strong financial position?


# Q9 How satisfied are you with the standard of maintenance of Council infrastructure (for example roads, footpaths, bridges, buildings, parks)?







#### **General Rates**

General Rates are based on land value and in NSC, comprise of three types

Farmland (comprising 58% of the rate income)

Residential (comprising 33% of the rate income)

Business (comprising 9% of the rate Income) General rates are increased each year by a percentage approved by the Minister for Local Government and based on a determination by IPART

Charges for water, sewerage and waste are set separately and are not part of this process. Income from these charges cannot be used for general purposes



#### Special Variations

Where Councils are unable to secure their financial future based on the normal rate peg the legislation provides for an application for a "Special Variation" (SV)



Temporary or permanent an SV application requires the Council to prove its financial position, asset renewal capacity and operational efficiency and consult with its community.



79 of the Councils in NSW have applied for an SV since 2016

  - i. under section 508A of the Local Government Act 1993 for increases to the ordinary rate income of 25.5% 2024-25 (including the rate peg), and 18.0% 2025-26 (including the rate peg) representing a total cumulative increase of 48.1% over a two-year period, with those increases to be permanent increases retained within the rate base and:
  - ii. under section 548 of the Local Government Act 1993 for the Minimum ordinary rate for Residential Ordinary and Business Ordinary categories to be set at \$640.00 for 2024-25 (including the rate peg) and \$755.00 for 2025-26 (including the rate peg) and the minimum ordinary for Business Narrandera category to be set at \$715.00 for 2024-25 (including the rate peg) and \$845.00 for 2025-26 (including the rate peg) representing a cumulative increase of 48.1% (including the rate peg) with that increase to be a permanent increase retained within the rate base.
- Includes the submissions received during the community engagement process relating to the proposed special variation and the Community Consultation Outcomes Report in the application to IPART.
- 4. Adopts the revised 2022-26 Delivery Program and LTFP with the Scenario two Two-year Special Variation option Long Term Sustainability.

- Recognises that the LTFP so adopted shows Council as sustaining continuing operating surpluses from 2024 and having positive cash flow from 2023.
- 6. Recognises the impact of the proposed increase on the properties currently rated as "Farmland" and requires the General Manager to report to Council prior to 30 June 2025 on the appropriateness of the current balance of rates income.
- 7. Authorises the General Manager to implement the improvement plan as adopted by Council in June 2023 and to report to Council six monthly on outcomes of that implementation

An application will now be prepared for IPARTs consideration.

## 1. PURPOSE

Council is committed to providing the community with accurate and timely information about Council activities, opportunities and initiatives that may impact or interest them.

The purpose of this community engagement is to ensure that the community is adequately informed and consulted about the impact of the proposed special variation and the impact of not applying for a special variation.

The objectives of this community engagement process include:

- To present the proposed SV.
- To identify the impact of the SV on the average rates across each rating category.
- To exhibit an updated LTFP demonstrating the impact of the proposed SV on Council's operating results from 2023-24 for feedback and final endorsement by Council.
- To communicate to the community the timeline and process for any potential SV application.
- To gather and consider the community's feedback to inform Council's final decision on whether and how to move forward with an SV application.

### 2. APPROACH

Council will utilise a three-phase approach to inform, consult, and conduct a public exhibition period, concerning the IAP2 Public Participation Spectrum below as listed in Council's Community Engagement Policy.

To meet the assessment criteria for an SV application, Council must:

- Demonstrate that the need and purpose of a different rate path for Council's General Fund is clearly articulated and identified in Council's Integrated Planning and Reporting (IP&R) documents.
- Show evidence that the community is aware of the need for and the extent of a rate rise.
- Show that the impact on affected ratepayers is reasonable.
- Exhibit, approve and adopt the relevant IP&R documents.
- Explain and quantify the productivity improvements and cost containment strategies in its IP&R documents and/or application.
- Address any other matter that IPART considers relevant.

To meet criterion two, Council would only need to undertake engagement at the "inform" level, but a "consult" level would ensure it more fully meets criteria one and four.

# 2.1 Phase 1 – Create community awareness and provide information.

Council will release information through various communication channels:

- Advising that Council plans to apply for an SV.
- Explaining why Council proposes to apply for an SV.
- Providing details about what the SV is, and
- Providing an overview of the process, which includes a detailed proposal and consultation process with an accompanying timeline.

The process began with a report to the August 2022 Council meeting Revised Rating Methodologies and associated resolution 22/199. This was followed by announcements at 2023 Listening Posts information sessions held at Narrandera (Facebook live streamed), Barellan, Grong Grong and Sandigo.

### 2.2 Phase 2 – Consultation

The consultation phase will provide various avenues and opportunities for the public to provide their opinions and feedback on the SV proposal options and Council's existing service level regarding satisfaction versus expectation.

It will also provide multiple opportunities for the public to:

- Directly engage with Council on these matters
- Better understand Council's current financial position and existing service level ability, compared to the future feasibility of maintaining service levels should there be no application for an SV.

## 2.3 Phase 3 – Public Exhibition

This will consist of a comprehensive proposal detailing financial scenarios and the impacts on Council services and programs. It will include drafts of key documents, including the Revised Community Strategic Plan, Delivery Program, Operational Plan, fees, Long Term Financial Plan, Workforce Management Strategy, and revised Asset Management Strategy.

Council prepared a revised Asset Management Strategy with consultants Morrison Low which was presented to the April 2023 Council meeting, before being publicly exhibited between 19 April-17 May 2023. The Revised Asset Management Strategy was adopted at the September 2023 Council meeting.

### 8. EXPECTED ENGAGEMENT OUTCOMES

These methods will aid in the statistical and qualitative data analysis of the community opinion on the proposed SV options and community understanding of the level of investment required for service levels.

The community feedback will allow the Council to make informed decisions and, where necessary, amendments to the SV proposal, Community Strategic Plan, Delivery Program, Operational Plan and Resourcing Strategy as part of the Council's submission to the IPART.

### 9. KEY MESSAGES

It is important to communicate to the community those aspects that are negotiable and those that are not. Council has identified two non-negotiable aspects:

- The legislative requirement to adhere to sound financial management principles, and
- Addressing the current core deficits in the Council's base case scenario.

To ensure the community's opinion is considered, their feedback is sought on the level of SV required to ensure financial sustainability. Community engagement activities, and a background paper outlining the need for and financial impact of the SV, will be presented to facilitate communication.

Key messages in all community communications and collateral will include how members can gain additional information or have their questions answered, how to provide feedback regarding the proposed SV increase, and what to expect once the community engagement activities have been completed, including the IPART's public submission and assessment process.

### 10. OTHER KEY POINTS

To ensure the community is well-informed, the materials provided will have quality content, clarity, and timely delivery.

Key information to be included:

- Definition of an SV.
- Explanation of why an SV is under consideration.
- Explanation that the proposed SV is a permanent rate increase that will be maintained in the rating base.
- Explanation of what the additional income from the proposed SV will fund.
- Sufficient opportunity for ratepayers to gain an understanding of the proposal.
- Simplified presentation of information with clear and concise messaging.
- Easily accessible and informative material.

- Use of charts, tables, and explanatory text to make financial calculations easy to understand.
- Average annual rate increases, and total rate increases in dollars for residential, business, and farmland ratepayers.
- Actions by the Council to become more financially sustainable.
- Review options available for consideration.
- Overview of how ratepayers can provide feedback and participate in the process.

The goal of the communication plan is to provide clear, concise, and accessible information for the community, inviting them to actively participate in the decision-making process.

#### 11. ENGAGEMENT REPORTING

To provide a comprehensive record of the community engagement process and ensure maximum participation, a final report will be generated. It will detail the planning, activities, outcomes, and extent of community engagement with all relevant stakeholder groups.

To gauge the level of participation in the engagement process, the following measures will be applied:

- Number of SV-related inquiries processed by customer service staff.
- Attendance records for public forums.
- Number of submissions received on the SV proposal.
- Number of unique survey responses.
- Click-through rate for the engagement site pages.

Where possible, demographic information will be collected from participants to ensure representation of the Shire community and that all relevant groups have been engaged, including those often harder to reach.

The aim is to obtain accurate data that assesses the level of community engagement, to provide a complete understanding of stakeholder participation in the SV decision-making process.

### 12. REPORT TO COUNCIL

Included in the report to Council are the results of community engagement, presented scenarios to be deliberated by the Council, as well as the determination whether to proceed in formally submitting an SV application to the IPART.

### 13. MONITOR RISK

Council's communication and engagement team will monitor the level of engagement during the consultation process. Council's General Manager must approve any proposed alterations to the plan before implementation.

# **Background**

At the Council meeting on 19 September 2023, Council resolved to go to the community and consult on a proposal to apply to the Independent Pricing and Regulatory Tribunal (IPART) for a permanent Special Variation (SV) of either:

- a one-year SV of 41.5% in 2024-25 (including the forecasted rate peg of 3.%), or
- a two year SV of 25.5% in 2024-25 (including the forecasted rate peg of 3.5%) and 18.0% in 2025-26 (including the forecasted rate peg of 2.5%), representing a cumulative Special Variation of 48.1% over two years.

This Q&A is part of a suite of documents that can be accessed on Council's website <a href="Special Variation">Special Variation</a> | Narrandera Shire Council (nsw.qov.au) and provides details of the proposal and the background information that led Council to make the decision.

# 1. What is a Special Variation (SV) and Rate-Pegging?

Normally general rates increase each year in line with an amount set by IPART. This amount is calculated annually based on methodology including a local government cost index and is commonly called the 'rate peg'.

For the 2023-24 financial year, the rate peg applied to NSW councils including Narrandera Shire Council is 3.7%. An assumed rate peg of 3.5% for 2024-25 and 2.5% for 2025-26 is being utilised as an estimate for the purposes of this consultation.

If a council's rate revenue is not sufficient to maintain service levels, undertake capital renewals and ensure sustainability, it can apply to IPART to increase general rate revenue by more than the rate peg. This is known as a Special Variation (SV).

To apply for an SV, councils must demonstrate to the community and IPART that they need the money and have implemented improvements to be as efficient and productive as possible. Since 2016-17 79 of the state's 128 general-purpose councils have applied to IPART for an SV. Those increases have varied from just 6.3% (Tweed) up to 92.8% (Strathfield). An annual list of approvals is published on the IPART website Media Release (nsw.qov.au)

# 2. Is the SV increase permanent?

Yes, in this instance. If approved, the proposed SV will increase the general rate base permanently, commencing in 2024-25. The rate base as from 2025-26 for option one, or from the 2026-27 for option two, will increase by the annual rate pegging limit as set by IPART.



### 3. What will the SV fund?

If implemented the special variation will generate an additional \$2.3m. These funds will be used as follows:

- Ensure financial sustainability.
- Upgrade of the Narrandera stormwater system (loan repayments on Council's share of that cost).
- · Maintain existing service levels.
- Staff salary system improvements.
- Technology upgrades including cyber security and a new enterprise management system.
- Compliance including the Audit Risk and Improvement Committee and risk management.
- Infrastructure renewals to reduce the backlog in asset conditions.

# 4. Why is this increase in rates necessary?

Council's income from rates has not kept pace with increases in expenses and this has meant that Council has over time become unsustainable and almost totally dependent on grants for capital renewals. The need to upgrade the stormwater system in Narrandera is an important component of the challenge faced by Council, but it is only one of many factors impacting the long-term sustainability of the organisation.

The combined effects of ongoing rate pegging at levels below actual cost, fair value accounting for assets, increasing compliance costs, and growing community expectations fuelled by the Independent Pricing and Regulatory Tribunal process have taken their toll.

# 5. If Council has \$36 million in the bank why is this increase necessary?

Council holds \$36,279,382 in reserves, but only a small proportion is unrestricted or unallocated.

- \$19,973,503 is externally restricted and belongs to waste, water, sewer and unexpended grants, bonds, and crown reserves.
- \$16,091,874 is internally restricted for plant and vehicle replacement, employee leave entitlements, incomplete works, and the pre-paid Financial Assistance Grant.
- Only \$214,006 remained unallocated on 30 June 2023.

Following extensive community consultation, should Council resolve to apply to IPART for a Special Variation, members of the public will also be able to make a submission to IPART in February 2024.

# 7. Will water and other charges increase?

The SV will apply to your general rates only and will not apply to the waste management, water, and sewerage services, which are all funded through separate fees and charges. Those fees and charges are likely to increase for other reasons but are not affected by the SV.

# 8. How much additional revenue will this generate in 2024/2025?

The proposed SV is anticipated to generate an additional revenue of \$2.3M which will be used to fund asset renewals, compliance costs associated with risk management, the Audit Risk and Improvement committee activities, a new enterprise management system that will allow contemporary access for the community and agencies and will equip Council to meet the challenges and opportunities of the future.

It will also help fund increases in staff salaries to keep pace with the local government market and allow Council to recruit and retain qualified and competent staff. Over time residents will see an ongoing improvement in assets as renewals occur.

# 9. Does this SV guarantee no future SVs?

This SV will allow Council to become financially sustainable in the General Fund to maintain existing services and provide the capability to grow. Future regulation changes, additional State Government cost shifting, and capital works programs as determined by the asset management systems and Councillors may influence the need for future SVs.

# 10. With the cost of living going up so much now, how can we be expected to manage this increase?

The proposed SV is not a decision taken lightly. Council recognises the delicate balance between providing essential services, maintaining infrastructure, and ensuring affordability for our residents. Council offers the Pensioner Rebate Scheme, which financially supports this important group in our community. Council also has a Hardship Policy to accommodate the special needs of those unable to pay their rates in full on time.

# 11. What is Council doing to remediate the situation?

Regardless of whether an SV proceeds, Councillors and staff are committed to continuing to ensure that Council operates as efficiently and effectively as possible. Every area of operation is under review – a process that commenced several years ago and is ongoing.

# 12. What do land valuations have to do with my rates?

The NSW Valuer General's Office is responsible for the valuation of all rateable land in NSW and land is revalued every three (3) years. Rateable land within the Narrandera LGA was revalued during 2022 and these values were used to calculate rates for the 2023-24 rates. Of itself, the land revaluation process does not provide any additional rate revenue for Council. The total increase in rate revenue to Council is capped on an annual basis by the IPART. For the 2023-24 year, the rate cap increase is 3.7% above the 2022-23 level.



Changes to land values will impact the rate amount payable for individual properties, but the total increase in rate income received by Council for the year does not exceed the rate cap as determined by IPART.

Whilst we acknowledge that some individual assessments have moved by much greater than the 3.7% rate pegging figure, many have also increased by less and in fact, some assessments have reduced in line with new land valuations.

# 13. What is the alternative to the proposed rate increases?

Without a Special Variation, Council would need to reduce the levels of service provided to the community to save costs and would not have the resources to fund asset renewals. Council would be reliant on grants to fund asset replacements. The stormwater project could not proceed unless 100% grant funded, and similarly the new industrial estate, deepening Lake Talbot and the proposals at the airport could not proceed without grants. Fees for the use of facilities would have to be reviewed.

Examples of services that would be impacted include the library, visitor information centre, parks and gardens, road maintenance and administration services. Cutbacks in these areas would result in a substantial reduction in staff numbers.
