RE: SRV application - North Sydney Council

Precinct** wish to express opposition to the 7% SRV application by North Sydney Council (NSC).

Our reasons for opposing the rate increase are:

• Lack of demonstrated need for the increase

We are not convinced that NSC has demonstrated fully that Council needs to generate the additional revenue it requires for the projects publicly stated through rate increases - the community has not been provided with adequate information on alternative revenue sources as part of its funding proposal.

• Lack of community support for rate increase

We are not convinced that the majority of the community actually demonstrated support for the special variation and the associated program of expenditure.

Evidence for the lack of support for a 7% increase can be seen in the results of the online and email community surveys which show **the majority of respondents (51%) want a rate peg only increase.**

51% Scenario 1 – rate peg only

18% Scenario 2 – 5% increase

21% Scenario 3 – 7 % increase

The random survey results showed that Scenario 2 was the preferred option.

This demonstrates clearly that the community does not support a 7% increase.

• Insufficient information provided to the community and inconsistent linking of Community's wishes to the Community Strategic Plan

The public consultation material (flyer) did not provide a sufficient or balanced explanation of Scenario 1 (rate peg only).

The community was not consulted regarding the proposed list of discretionary services which the flyer states will need to be cut if Scenario 1 was adopted.

The community was not consulted about the projects listed as needed in Scenario 2 & 3. These two scenarios are also misleading as they list projects which were not specifically stated in the North Sydney Community Strategic Plan 2018-2028. eg Badangi Reserve Walking Trail \$180,000

In addition the \$3 million for Neutral Bay & Cremorne Villages may no longer be required to be funded entirely from rates given that NSC signed a funding agreement with Transport for NSW late 2018 (Council Meeting Minutes 29.10.18) for a similar amount to upgrade streetscapes in these villages as a result of the B-line bus project.

For these reasons, Precinct Is not satisfied that the purpose of the special variation is consistent with the community's objectives identified in the council's 2020 Vision – Community Strategic Plan 2018 – 2028.

In summary, for all the reasons stated above, Precinct does not North Sydney Council's application for a 7% rate increase.
