# Background



Camden Council has determined a requirement for a special rate variation (SRV) in order to maintain and improve the LGA's infrastructure.

As part of the special rate variation application process, Camden Council conducted a robust community research survey, with the following key objectives:

- 1. To measure community support for the continuation of a special rate levy
- 2. To provide an avenue for feedback in order for residents to express their views on the proposed SRV



The phone survey will provide Camden Council with a robust and statistically micromey valid measure of community response to the proposed SRV program

In order to assess the community's response to the special rate variation, Camden Council commissioned Micromex Research to conduct quantitative research within the LGA.

### Specifics of the Survey

- Random telephone survey with n=400 residents aged 18 y/o +
  - The sample was weighted by age to reflect the 2011 ABS Census data
     Participants were asked some profiling questions, then specific questions
    - relating to the proposed special rate variation
- Fieldwork was conducted on the  $4^{th}$  &  $5^{th}$  of February 2013

A sample size of 400 residents provides a maximum sampling error of approximately +/- 4.9% at 95% confidence



• The questionnaire was designed to establish current attitudes and explore community response to the proposed resource strategies

- QA. Confirmation that respondent does not work for Council
- QB. Age group
- QC. Number of years lived in the area
- QD. Suburb of residence
- Q1. Satisfaction with the quality of infrastructure currently provided by Council in the local area
- Q2. Satisfaction with the level of long term planning provided by Council
- Q3. Importance of Council implementing programs and programs to maintain/renew infrastructure in the area

Q4. Awareness of the existing Community Infrastructure Renewal Program

#### **CONCEPT READ**

- Q5. Support for the proposed continuation
- Q6. Importance of Council being allowed to continue this levy

The questionnaire was developed in conjunction with Council staff



#### **Ratings** questions

The Unipolar Scale of 1 to 5 was used in all rating questions, where 1 was the lowest importance, satisfaction or support and 5 the highest importance, satisfaction or support.

1.99 or lower	'Very low' level of importance/satisfaction/support
2.00 - 2.49	'Low' level of importance/satisfaction/support
2.50 – 2.99	'Moderately low' levels of importance/satisfaction/support
3.00 – 3.59	'Moderate' level of importance/satisfaction/support
3.60 – 3.89	'Moderately high' level of importance/satisfaction/support
3.90 - 4.19	'High' level of importance/satisfaction/support
4.20 - 4.49	'Very high' level of importance/satisfaction/support
4.50 +	'Extreme' level of importance/satisfaction/support






## Profile of Sample






Q. How satisfied are you with the quality of long term planning for local infrastructure provided being by Council in the local area?

## Response to the SRV Concept

Currently, Camden Council ratepayers have been paying a special rate variation of 4.5% to fund urgent infrastructure renewal works as part of the Community Infrastructure Renewal Program. The objective with this program is to greatly reduce the backlog of ageing infrastructure without compromising existing services to ratepayers.

Funds collected over the past 3 years have been allocated to road reconstruction projects, footpath and cycleway upgrades, parks and playground equipment and community building improvements.

Currently this levy is approximately \$50 per year to the average rate paying household, however, it will expire at the end of this financial year.

Council is seeking to continue the Community Infrastructure Renewal Program for a further 6 years but not at the existing 4.5% level. Rather Council is proposing an increase to rates of only 1.1%, which will last for 6 years and is above the Minister's allowable rate increase which is 3.4% in 2013/14.

Therefore in year one the total increase will still be 4.5%, as this includes the rate peg, so approximately \$50 per year to the average rate paying household, however, the actual levy is only \$13 per annum for the average residential property, the remainder of the \$50 being the Minister's rate increase.


The \$2.5m generated from this rate continuation will partly fund a \$6m program of works over the next 6 years. The other \$3.5m will be sourced from a low interest loan from the State Government and the utilisation of Council's internal reserves.

Residents were given the opportunity to have the statement read multiple times to ensure they felt comfortable that they understood the SRV concept




The levy is seen to both affordable and required

The proposed Community Infrastructure Renewal Program is a \$6 million program of works over 6 years commencing July 2013. The funding would be directed to the following areas:

Proposed Special Rate Variation to Continue the Community Infrastructure **Renewal Program** 



#### INTRODUCTION

In 2010, Camden Council applied for a special variation to rates of 4.5% (excluding the then approved 2.6% Ministerial rate increase) in order to fund urgent infrastructure renewal works. Across Local Government in NSW there have been significant funding shortfalls for infrastructure renewal, and Camden is like most other councils in that there is a backlog of work that needs to be undertaken in order to keep infrastructure up to a satisfactory standard.

In 2010, Council's initial application to fund a Community Infrastructure Renewal Program was approved by the State Government for a period of 3 years only. Whilst this rate increase and the 3 year period in which it applies is no where near sufficient to address the funding shortfall, it did finance a \$3.68m program of critical works. The following table is a reflection of where funds have been allocated with the monies raised from the current special rate variation.

Council is intending to continue part of the special rate increase beyond 2013 to ensure that community infrastructure throughout the Local Government Area is renewed for the continued enjoyment of the current and future community.

#### WHY WE ARE PROPOSING TO CONTINUE THE COMMUNITY INFRASTRUCTURE RENEWAL PROGRAM

#### 1. We want to be able to renew community infrastructure without having to reduce other services to residents

Camden Council is committed to improving the quality of life of residents in the Camden Local Government Area. Feedback Council has received, via surveys, indicates residents are very satisfied with Council's performance in delivering services and facilities throughout the area. Addressing this funding shortfall, partly through a small rate variation, will enable Council to continue to provide these services and facilities into the future at the levels enjoyed by the community today.

2. Local Government across NSW is finding it increasingly difficult to fund infrastructure renewal due to rising costs and ageing infrastructure

Funding shortfalls for infrastructure renewal is a well-documented problem facing Local Government. In NSW alone it was estimated in 2005 that the renewal backlog was around \$6 billion, and forecast to rise to almost \$12 billion by the year 2020. Local Government has faced rising costs over many years, without capacity to meet these costs with additional revenue.

#### 3. We know we have a significant shortfall in funds to undertake necessary work, and if not addressed the situation will continue to get worse.

In November 2012, Council identified an asset renewal backlog, or funding shortfall, of \$12.6 million, which is expected to increase each year until such time as additional funds are available for reducing the backlog. The extension of the Community Infrastructure Renewal Program, funded in part through a special rate increase beyond 2013, would ensure that this shortfall continues to be addressed.


#### 4. We know that the community has concerns about the state of many types of local infrastructure

Council surveys residents on a bi-annual basis in relation to community satisfaction with Council services. Services relating to community infrastructure, particularly local roads and transport, natural areas and waterways, and asset management generally, have been those services identified as greatest priority by residents in the previous two surveys. Management of parks and playgrounds were also areas that reflected some community dissatisfaction in 2011.

#### 5. There are risks associated with not keeping up with asset renewal

Many of the assets in Council's care perform essential functions throughout the area, such as drainage and stormwater management, and basic accessibility through roads and footpaths. These assets need to be kept to a satisfactory standard through appropriate maintenance and renewal for the basic safety and functioning of the local area, in addition to the important contributions they make to the quality of life and amenity we currently enjoy.

By not continuing this Program, Council will have insufficient funds to ensure essential infrastructure is renewed, leaving an unreasonable burden on future generations to address.



#### WHAT THIS MEANS FOR YOU

Council has been mindful to keep the proposed rate variation to a minimum.

Importantly, the current 4.5% Special Rate Variation will be removed as at 30 June 2013 and replaced by a 1.1% special rate variation, effective from 1 July 2013 for a period of 6 years.

#### HOW WILL THE COMMUNITY INFRASTRUCTURE RENEWAL PROGRAM BE FUNDED?

Camden Council is proposing to continue the Community Infrastructure Renewal Program for 6 more years, to the value of \$6 million (\$1 million annually). This is to be funded by the following sources:

IPART has already determined a 3.4% general rate increase for 2013/14. The proposed 1.1% special rate variation would take the overall total rate increase for 2013/14 to 4.5%.

The proposed total 4.5% rate increase is exactly the same as the current 4.5% rate increase being paid by ratepayers. In essence, average rates will remain the same in 2013/14 when compared to current 2012/13 average rates. This is shown in the table below.
