## Tender Approval Request for the Supply of Natural Gas to the Central Ranges Region of NSW

## **Invitation for Submissions**

The Independent Pricing and Regulatory Tribunal of NSW (IPART) and the Australian Competition and Consumer Commission (ACCC) have received a Tender Approval Request (TAR) from the Central Ranges Natural Gas and Telecommunications Association Inc (CRNG&TAI) for the supply of natural gas to the Central Ranges region of NSW.

The CRNG&TAI seeks to facilitate the extension of a gas transmission pipeline from Dubbo to Tamworth and reticulation of gas within the region, as outlined in the proposed tender documents.

In accordance with the National Third Party Access Code for Natural Gas Pipeline Systems ("the Code"), IPART and the ACCC are required to inform interested parties of the TAR via a notice published in a national daily newspaper, and invite submissions.

After due consideration of any public submissions, IPART and the ACCC will independently approve or disapprove the TAR, according to criteria outlined in the Code, as it relates to distribution and transmission respectively.

Submissions should address matters upon which IPART as regulator for distribution, and the ACCC as regulator for transmission, of natural gas will base their decisions on whether to approve the TAR. These matters are listed in section 3.28 of the Code, and outlined in the issues paper.

Submissions should be submitted in both written and electronic form. All submissions, marked "Central Ranges Natural Gas Tender Approval Request", must be mailed or hand delivered to <u>either</u>:
