Are there concerns with the prices councils charge for domestic waste management services? Why/why not?	Yes, high costs of waste management – usually half of rates notice costs – even for those residents who don't have enormous amounts of waste, i.e. pensioners who only receive a maximum of \$250 grant from the NSW Government. This grant is always well received, but should have been increased over many decades.

IPART should insist that councils be legislated to have composting of putrescible waste and green waste, available for disused mine sites and farm rehabilitation. Waste costs should be reduced in NSW due to recycling.
